### NEW RESTRICTION FROM MINNEAPOLIS CONVENTION CENTER

In order to protect lobby floors, the Minneapolis Convention Center is requiring that exhibitors that exhibit within an Exhibit Hall must enter and exit using the rear marshalling yard during approved move-in / move-out times of an event when transporting exhibit items that require a cart or cannot be hand carried. Exhibitors may use the front lobbies during approved move-in / move-out times for small hand carry items at a designated entrance.
